INFORMATION for APPLICANTS

- The current Committee must consider each application made at a Committee meeting prior to the AGM and must at that meeting or the next meeting accept or reject that application.
- If your application is accepted, your name and address, as provided above, must be recorded in a register of members and be made available to other members, upon request, under section 27 of *Associations and Incorporation Act 1987 (WA)*. You are entitled to inspect and make a copy of the register of members.
- If your application for membership is rejected you may give notice of your intention to appeal within 14 days of being advised of the rejection. NAIDOC Perth in a general meeting, no later than the next annual general meeting, must confirm or set aside the decision of the Committee rejecting your application, after giving you a reasonable opportunity to be heard or to make written representations to the general meeting.
- If the obligations under the *Associations and Incorporation Act* are not complied with NAIDOC Perth can be wound up.

QUALIFICATIONS FOR MEMBERSHIP OF NAIDOC PERTH

(1) Membership of NAIDOC Perth is open to Aboriginal & Torres Strait Islander people who are:

- aged 18 years and over;
- a citizen of Australia; and
- currently residing in Perth, Western Australia.

(2) A person who wishes to become a member must:

- Apply for membership to the Committee in writing in such form as the Committee directs; and
- be proposed by one member and seconded by another member.
